### **Statement of Limited warranty**

The warranties provided by Compu-Lock in this Statement of Limited Warranty apply only to the ThinkPad 570 Direct Dock Adapter you originally purchase for your use, and not for resale, from Compu-Lock or your reseller. Unless Compu-Lock specifies otherwise, the following warranties apply only in the country where you acquire the Adapter. If you have any questions, contact Compu-Lock or your reseller.

## Warranty

Compu-Lock warrants the ThinkPad 570 Direct Dock Adapter to be free of defects in material and workmanship for a period of one year. If your ThinkPad 570 Direct Dock Adapter proves defective in materials or workmanship during this period, Compu-Lock will promptly repair or replace it.

#### **Warranty Service**

You may be required to provide proof of purchase.

Compu-Lock will provide certain types of repair and exchange to restore your Adapter to good working order.
